

## **Agreement for Collaboration**

This Agreement is made on this day, 7<sup>th</sup> January 2025 by and between:

DCT's Dhempe College of Arts and Science, located at Miramar, Panaji-Goa herein referred to as "Dhempe College", and

Aaji Care, located at Ella Village, Old Goa, Goa, herein referred to as "Aaji Care".

WHEREAS:

1. Dhempe College is committed to providing its students with opportunities to gain practical experience and enhance their academic learning through internships.
2. Aaji Care, Panaji, is interested in collaborating with academic institutions to offer internship opportunities that contribute to the development of future professionals.

NOW, THEREFORE, both parties agree to collaborate under the following terms and conditions:

### **1. Objective**

The primary objective of this Agreement is to establish a collaborative partnership to provide internship opportunities to students of Dhempe College, enabling them to gain practical work experience in their respective fields of study.

### **2. Scope of Collaboration**

#### **2.1 Internship Opportunities:**

Aaji Care agrees to provide internship opportunities for students of Dhempe College, in accordance with the requirements of the College's academic programs.

#### **2.2 Internship Duration and Structure:**

The duration and structure of the internships will be mutually decided by both parties, keeping in mind the academic calendar of Dhempe College and operational requirements of Aaji Care.

#### **2.3 Selection Process:**

The selection of students for internships will be conducted jointly. Dhempe College will provide a list of eligible candidates, and Aaji Care will conduct further screening based on its criteria.

#### 2.4 Supervision and Mentorship:

Aaji Care shall assign appropriate mentors/supervisors to guide the interns throughout the internship period, ensuring a valuable and structured learning experience.

### 3. Roles and Responsibilities

#### 3.1 Responsibilities of Dhempe College:

- To provide a list of eligible students who meet the internship criteria.
- To coordinate with Aaji Care regarding the academic schedule and student availability.
- To monitor the progress and performance of the interns in coordination with Aaji Care.

#### 3.2 Responsibilities of Aaji Care:

- To offer meaningful work experiences that align with the students' academic programs.
- To ensure that interns receive appropriate training, guidance, and supervision.
- To provide feedback on the performance of the interns to Dhempe College.

### 4. Confidentiality

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the course of this collaboration. The interns will also be required to adhere to any confidentiality agreements set forth by Aaji Care.

### 5. Termination

This Agreement may be terminated by either party with a written notice of 60 days. In the event of termination, both parties will work together to ensure that ongoing internships are completed satisfactorily.

### 6. Amendments

Any amendments or modifications to this Agreement shall be made in writing and signed by both parties.

### 7. Duration of Agreement

This Agreement shall be valid for three years from the date of signing and may be renewed upon mutual consent of both parties.

### 8. Dispute Resolution

If any disputes arise from this Agreement, both parties agree to resolve the matter amicably through discussions.


