1.2. Institutional SWOC Analysis

Strengths:

1. Innovative teaching-learning strategies (blended and hybrid learning, ICT and LMS integration) have been implemented to supplement traditional methods. Teachers are engaged in e-content development and MOOCs.
2. Timely adaptation to diverse learning environments and modes has been undertaken.
3. Emphasis is given to skill-enhancement through Skill Development Cell and Institution's Innovation Council.
4. Interdisciplinary approach towards organising conferences, seminars and research projects is adopted.
5. Progressive efforts have been made in developing research culture among faculty members; this, in turn, has given impetus to research by students through presentations and webinars.
6. International exposure for teachers and students through participation in conferences and student exchange programmes abroad is facilitated with strong Management support and collaboration with nodal academic bodies.
7. In concurrence with the National Mission for Clean and Green India, the institution's forte is its extension activities and the College has obtained Green Certification level III in accordance with green standard GSCP-01-2010.
8. A strong drive to recruit the best faculty with high technological skill and research aptitude has been maintained, taking into consideration inclusiveness.
9. Higher number of female students and faculty members in the institution has enabled to address issues of gender inequities.

Weaknesses:

1. The institution is situated in the capital city; hence facilities such as in-house auditorium and playground cannot be made available in the campus due to paucity of space.
2. Despite applying for grants from research funding agencies the Institution has not received substantial research grants.

Opportunities:

1. Development of entrepreneurial skills among students can be strengthened.
2. More collaborations with industry, academic and cultural institutions can be undertaken.
3. On-campus placement can be bolstered through a more robust industry interface.
4. Sharing knowledge and expertise globally through online mode can be undertaken especially due to enhanced adaptation to teaching-learning in digital mode.
5. Multilingual proficiency of students and general public can be enhanced especially through software solutions in Digital Language Laboratory and Skill Development Centre (DLLSDC) and in-house knowhow of faculty members in designing e-content.
6. Contribution to National Massive Open Online Courses (MOOCs) can be undertaken.
7. Students' participation in international events can be increased through more intensive guidance.
8. Global learning interactions can be facilitated through digital mode.
9. Developing an ecosystem for multidisciplinary education by forming a cluster.
10. To setup an incubation cell to convert the innovative ideas into startups.

Challenges:

1. Drastic reduction in number of students in science stream, thereby affecting workload.
2. Though alumni participate in college programmes, the participation needs to be translated into stronger financial support for the institution.
3. Managing skill development courses, co-curricular activities and personality enhancement programmes along with academic requirements has been difficult due to overall time restraints.
4. Developing an ecosystem for multidisciplinary education by forming a cluster of colleges will have challenges as regards geographical, financial and logistic (timetable) management.
5. Converting the innovative ideas into startups through incubation cell.

2.6. Teaching, Learning and Education Technology

The Directorate of Higher Education, Government of Goa, has set a deadline for the implementation of the NEP 2020 in the state of Goa as March 2023. Hence, vide its circular dated 30/03/2022, has instructed all the institutions under its purview to set up the Teaching, Learning and Educational technologies cell under NEP 2020. Under this cell, the institution plans to make extensive use of technology in teaching and learning, remove any existing language barriers, make information easily available for Divyang students and proper educational planning and management as envisaged in the NEP 2020 policy.

Implementation of OBE:

Under the aegis of the Directorate of Higher Education, an FDP on “Outcome-based Education: Assignment and attainment of Course outcomes (COs) and Program outcomes (POs)” was organized for all faculty members of the institution on 3rd June 2022. This will help in necessitating a focused approach on the attainment by the students keeping in mind the expected graduate attributes, enhance their teaching-learning experience that will help the students in achieving the expected attributes and the defined COs.

Faculty members are encouraged to design new learning assessment methods that will help in measuring the progress in achieving the expected COs and attributes by the students.

Enhancement of student progression:

- Increasing teacher-student contact in and out of class to bring about better motivation and involvement and encouraging their commitment to learning.
- Encourage peer learning to share ideas, improve thinking and help in deepening their understanding.
- Promote analytical thinking and apply it to daily life problems.
- Develop effective time management and study skills.
- Improvise diverse ways of learning by using different methods of pedagogy, use of ICT tools and blended learning that will help in addressing a wide spectrum of students.

Multidisciplinary teaching:

Education is no longer limited to a particular discipline under NEP 2020. Students will now be allowed to opt for subjects/courses from various disciplines such as art, music, architecture, fashion design, finance, yoga, sports from different institutions. The curriculum being flexible, learners will have an opportunity to choose according to their talents and interests. The Institution will provide the learners with courses that have multidisciplinary and holistic education beyond the boundaries of sciences, social sciences, arts, humanities and sports to create a multidisciplinary environment.

Areas of community service and engagement (participation in community service programs), environmental education (climate change, biodiversity and wildlife conservation, waste management) and value-based education (ethical values, life-skills) are some of the credit-based courses planned to be included in the curriculum.

The institution has begun the exercise of forming a cluster with a few institutions affiliated to Goa University such as Goa College of Home Science, Goa College of Music, DCT's S.S. Dempo College of Commerce and Economics, PCC College of Engineering, Nirmala Institute of Education, Sant Sohrobanath Ambiyee Government College of Arts and Commerce, Kala Academy Goa's College of Theatre Arts to name a few. This will help the institution in offering programs/courses of study to the learners such as languages, literature, music, art, dance, theatre, education, event management, accounting, pure and applied sciences and sports and several other subjects that are needed for stimulating a multidisciplinary learning environment.

MOOCs and ODL:

Digital Integrated System for Holistic Teaching and Virtual Orientations, an online initiative of the Directorate of Higher Education, Government of Goa, was taken up in the year 2020-21. Under this initiative, all faculty of the institution from both the BA and BSc programs were involved in preparing e-content in the language of English. These videos are available to the students in online mode through internet access at any time for reference and better understanding of the various topics under study. With, NEP 2020 highlighting extensive use of technology in teaching and learning, and more importantly removing language barriers, the faculty have now begun recording e-content in the local language, Konkani. A few faculty from the Department of Geology have offered their services under the Directorate of Higher Education for the preparation of course videos under SWAYAM.

Online Distance Learning, **ODL** : The Department of Physical Education conducted a 30 hour online course on Health & Nutrition during the academic year 2021-2022 . The course was recognized by Goa University and marks were granted to students on successful completion. The same has now been proposed to Goa University for consideration as a two-credit course.

The Department of English conducted 30 hours online course titled 'English Proficiency: Intermediate Level' for Japanese students of Meijo University during 2021-2022.

The institution plans to float skill development courses in online mode/ hybrid mode.

The institution hopes to achieve all the above in the shortest possible time of 2 years.
