Memorandum of Understanding

Dhempe College of Arts and Science, Miramar, Panaji, Goa (hereinafter referred to as "the College"), represented by Prof. (Dr.) P. S. Ramu Murthy, Principal, and

OneEarth Foundation, Goa (hereinafter referred to as "the Foundation"), represented by Mr. Ferdin Sylvester, Director.

Date -

Purpose

This Memorandum of Understanding (MoU) outlines the terms of collaboration between the College and the Foundation to foster academic interaction, provide internship opportunities, and facilitate joint projects in areas of mutual interest, particularly concerning environmental philosophy, ethics, and human responsibility. This MoU formalizes the partnership initiated through the Foundation's internship program titled "Nurture with Nature".

Scope of Collaboration

The College and the Foundation agree to collaborate on the following activities:

Internship Program: The Foundation will offer internship opportunities to students enrolled at the College. The internship program will focus on environmental issues, environmental ethics, behaviour change, or developing community engagement strategies related to environmental responsibility. The details of the internship program, including duration, selection criteria, and responsibilities, will be mutually agreed upon and outlined in a separate annex to this MoU.

Joint Projects: The College and the Foundation will explore and develop internship programs related to environmental philosophy, human behavior and behaviour change, community outreach programs promoting environmental awareness, or workshops and seminars on relevant topics. The specific details of each project, including objectives, timelines, and resource allocation, will be defined in separate project proposals.

Academic Interaction: The College and the Foundation can facilitate interaction through lectures, workshops, and activities related to environmental philosophy, ethics, and human responsibility.

Resource Sharing: Where feasible and appropriate, the College and the Foundation will share resources such as knowledge materials, lab facilities, and expertise to support collaborative activities.

Responsibilities

The College

Nominate/recommend/permit suitable students for the internship program.

Provide necessary support to students participating in the internship program.

Collaborate with the Foundation in the development and execution of joint projects.

Facilitate the organization of guest lectures, workshops, and seminars.

The Foundation Design and planning of the internship program. Provide mentorship and guidance to interns. Contribute expertise and resources to joint projects. Facilitate access to relevant resources and networks.

Term and Termination

This MoU will be effective for a period of 3 years from the date of signing and may be renewed upon mutual agreement. Either party may terminate this MoU with 2 months written notice to the other party.

Governing Law and Dispute Resolution

This MoU shall be governed by and construed in accordance with the laws of India. Any disputes arising out of or relating to this MoU shall be resolved amicably through mutual discussion.
